Financial Update

As we begin the new calendar year, we are also halfway through the financial year. Equestrian NSW remains dedicated to supporting the sport while striving to minimise fee increases. As a not for profit, our financial strategy prioritises breaking even each year while maximising support for members and events.

For the current financial year, membership fees for NSW members increased in line with CPI. This increase comprised:

- 0.8% increase in the ENSW component
- 7.4% increase in the component paid to Equestrian Australia comprising the insurance and administration levies





Half Year Financial Update

As of December, Equestrian NSW is forecasting a \$51,000 (3%) surplus for the financial year.

Forecast Financial Breakdown:

- Total income after EA National Administration and Insurance levies: \$1,463,406
- Forecast expenditure: \$1,412,255

Where Does the Money Go?



- 51% Managing the ENSW business (insurance, licenses, staff, and office costs)
- 32% Direct support to disciplines not operating as ENSW subcommittees (DNSW, JNSW, EvNSW, Driving, and Working Equitation)
- 4% ENSW-supported programs (Measuring, Education, and Membership Events)
- 4% Direct support to clubs via Safety and Activity Support Grants
- 4% Support for ENSW Committee activities (Vaulting, Para Equestrian, and Coaching)



The Equestrian NSW Board is currently reviewing cash holdings in line with guidelines from the Australian Institute of Company Directors to determine an appropriate cash reserve. Once this review is completed, it is anticipated that the Board will allocate additional funds to support strategic initiatives identified in the 2030 strategic plan-all targeted at growing and developing equestrian sport within NSW.



(Note: These figures exclude income and expenses from disciplines operating as ENSW subcommittees—Vaulting, Show Horse and Interschool, —which maintain separate bank accounts under ENSW.)

We extend our gratitude to the Equestrian NSW Finance and Risk Management Committee, comprised of independent ENSW members, who diligently oversee financial management to ensure funds are utilised solely for the benefit of members.
