#### 1. MEETING ADMINISTRATION

## 1.1 Open Meeting

Board President Brad Frankum opened the meeting at 7:33pm.

With a quorum of 62 present, the AGM proceeded.

#### 1.5 REVIEW OF PREVIOUS MINUTES

### 2022 Annual General Meeting

It was noted that that there were no changes required to the previous minutes

Motion: to accept the 2022 Annual General Meeting Minutes as a true and accurate record of proceedings.

## 2. CONFIRMATION OF BOARD POSITIONS

- Coco Miles and Amber Fuller have stepped down from the Board leaving two vacancies.
   Additionally Sue Cunningham and Lisa Winn had completed a term and were eligible for reelection.
- 9 members nominated for the four positions necessitating an election in which 256 members voted.
- Lisa Winn and Sue Cunningham were returned to the board. Alison McLean and Nicola Rockwell have been elected to the board.
- The Board is grateful to all who nominated and stood for election
- The new and returning members will join Brad Frankum, Amy Eggleton and Gillian Burns as the Board members in 2024.

#### 3. PRESIDENT'S REPORT

In addition to the written report Brad Frankum reported:

• Subsequent to the submission of the report the Australian Turf Club have made an unsolicited proposal to the NSW State Government regarding the sale of Rosehill Racecourse for housing

and the building of an equestrian centre of excellence at Horsley Park. The potential advantage is that funding could be provided for the upgrade of the SIEC facilities. Brad and Shane Rose will be meeting with the ATC in January to understand more about the proposal. ENSW will keep members informed of any development.

• During the year Vireena has been appointed as the permanent CEO of ENSW.

#### 4. CHIEF EXECUTIVE OFFICER'S REPORT

In addition to the written report Vireena Peacock reported:

- In April Suzanne Doyle facilitated a review and update of the strategic plan and it not clarifies the focus of ENSW on our Members, Governance, Finance & Ethics, Education and Excellence.
- Operational highlights were a significant number of National events run by ENSW and the
  Discipline committees including National Show Horse, Interschools, Dressage NSW ran AOR &
  Youth Championships, Australian Jumping Championships and the National Vaulting
  Championships.
- ENSW staffing has seen some changes with Jo Jennings moving to EA, Susie Burns relocating
  to the North Coast and working remotely and Mia Mondon and Ebony Ramm joining the
  office team.
- There has been a major focus on increasing awareness and compliance to Health and Safety
  of athletes and horses at events. This has included the introduction of the Safe 365 system
  allowing app based health and safety reporting as well as risk assessments. This system has
  been funded through Sport NSW and we are grateful for their help.
- The ENSW Education Committee is targeting officials education and how they can use common themes to build on-line modules that can be used for facilitating more accessible training for officials across all disciplines.
- ENSW organised for Mike Tomlinson, an international expert on horse welfare, to present an open ZOOM seminar on social license that was available to all ENSW members.
- ENSW is actively working with EA on how we can develop a shared services model that will create efficiencies and common standards across all Australian States.

## 5. FINANCIAL STATEMENTS & REPORTS

Vireena Peacock presented the Finance Report, noting:

- Revenue \$3.4 million predominantly through memberships
- Membership fees were not increased for the second year running to assist members recovering from recent events.
- A profit of \$265,000 was posted for the financial year vs a loss of \$95,000 the previous year.

Motion: That the 2022- 2023 Financial reports be accepted as presented.

Question: Sarah Munro asked: Could you please provide further information /breakdown about what 'Discipline Councils & Committee Expenses' include please?

Answer: Significant detail is provided in the Annual Report. Funding is provided to all disciplines after the submission and approval of an annual plan and budget by the ENSW Board. ENSW supports disciplines through funding for Official Education, Major Events, Administrative costs and High Performance Squads amongst other areas.

## 8. Appointment of Auditor

The appointed auditor DFK Laurance Varnay, has completed their second year as auditor, and the performance of the Auditor was assessed as satisfactory by the ENSW Board.

Motion: To appoint DFK Laurance Varnay, for a further two years as allowed by the constitution. Motion carried.

#### 9. General Business

Brad Frankum provided a commentary on the EA Reform process:

- A proposal has been provided to ENSW by EA
- ENSW have provided feedback to EA on their proposal and have engaged in active discussions with EA
- ENSW is working collaboratively with EA on the reform process

Question: Sarah Munro asked: I understand that Life Membership was once available to EA members. I am very interested in seeing that option becoming available to EA Members again. I request that this is discussed and considered by the board. thanks and regards Sarah

Answer: The Board has reviewed and renewed the Honorary Life Membership process and this is now available on the ENSW website. The purchase of Life Membership as was available some time ago is not being considered.

Question: Sally Barbera asked - Would like the Board to consider a 'conference' for all committee members to meet with the Board. Have spoken a bit with Vireena about this and think a face to face would be hugely beneficial.

Answer: Yes, this is being considered by the Board and is a welcome suggestion

Question: John Vallance asked - How close are we to having a National IT system?

Answer: EA has employed Anna Fitzgerald to scope the requirements of a new IT system. The scope is scheduled to be presented to the EA Board in May.
